PAYMENT DETAILS

- You cannot register without sending in your completed registration form (New or Renewal registrations):** You must forward your completed form to the BDC with your fee.
We cannot give numbers in advance.

Please note: We do Not accept photographed copies of forms
- We encourage you** to make your payment **by bank to bank** this is the quickest method. You can do this by ringing your bank or visit your branch, or internet payment (if you use internet banking just pay the amount over to the BDC account) clearly stating the payee, see below for bank details.
- The fee is £20 for 2020 for each competitor If applying for two competitors at the same time you should make one payment for the total fee of £40.00 but you **must** send both forms.
- Remember that Cheques take four working days to clear before we can start to process the application.
Payment by cheque or Postal Order made payable to the British Dance Council and sent with the form to the BDC office. Please do not send cash
- Please **do not** send your application by recorded or special delivery as there may not be anyone available to sign for the letter and will be returned to the sorting office.
- Note: If a competitor wishes to upgrade to a higher age group before they are eligible the parent or guardian must write to the BDC requesting permission to do so.

Adult 16 years and over (this includes Youth)

When making payment bank to bank: Please use reference **AM-COM / (Surname)** . THE SURNAME OF THE APPLICANT - (if paying for 2 competitors one surname will suffice as the reference (make one payment for the 2). [this should be the name on your form] and not the name of your business or your bank account.

Please forward an email stating you have made a bank to bank payment with the reference used and the amount paid to secretary@britishdancecouncil.info. Send your completed form at the same time as the fee. You may scan and email your form, however, **we do not** accept photographed forms.

Note: Please answer all the questions on the form. No licence will be issued without the correct fee and your fully completed Amateur Competitor registration form being received at the BDC office.
